In some instances, we are able to offer coverage on an admitted basis depending on the acceptability of the physician and the state in which they practice. **The General Star** companies are rated **A++** by A.M. Best and **AA+** by Standard & Poor's.

Wholesale brokers must be designated by General Star's Medical Professional Department to submit qualifying business for these programs.

Eligible Exposures

- > Physicians and Surgeons (All Specialties)

Ineligible Exposures

- > Full time *locum tenens*, nursing home practitioners, and emergency room physicians

HEALTHCARE FACILITY PROGRAM

Liability coverage is available to those entities providing direct medical care on an outpatient basis.

Eligible Exposures

- > Ambulance Services—ground or air, emergency and non;
- Ambulatory Surgery centers; Walk-in Clinics and Urgent Care centers; Medical Spas; Medical Laboratories;
- Blood / Organ / Tissue Banks; MRI / X-Ray/Imaging Facilities;
- Physical Rehabilitation centers; Cancer Treatment centers;
- Dialysis centers; Home Healthcare; Sleep centers, etc.

Ineligible Exposures

- > Hospitals; Nursing homes or other long-term care facilities;
- Directors & Officers liability; Managed care E&O; Staffing of hospitals or nursing homes
