The Criminal Justice Policy form offers the following General Liability and Professional Liability coverages:

All coverages are on an occurrence or claims-made basis with the exception of Employees Benefits and Employment-related Practices, which are claims-made only.

- > Minimum deductibles range from \$5,000 to \$25,000
