### Eligible Exposures

- > Executive protection security

### Ineligible Exposures

- > Airport security (passenger or baggage screening)
- > Nightclub and concert security

- > Strike security

### Target Accounts

- > In business for more than three (3) years
- > Annual revenue of less than \$10,000,000

### Available Limits

- > General Liability: \$1,000,000 per occurrence
- > Excess Liability: Up to \$5,000,000 in Excess limits available



### Submission Requirements

- > Five years of currently valued carrier loss information including carrier detail regarding individual claims
- > A completed and signed ACORD application
- > A completed and signed General Star Security Guard Application, or equivalent Security Guard Application
- > A copy of the standard client service contracts and indemnification agreements
